45.21 Apologies

Apologies received from Cllr Patrick Mulligan, Cllr Andy Brown and Cllr Steven Wood all due to work commitments.

46.21 Recording of Council meetings

There were no declarations of interest.

There was a halt in proceedings as one Member queried the election of the Chair at the May meeting stating procedure was not followed. Due to no Member offering to become Chair, Cllr Cohn offered to continue as Chair and was duly elected Chair for 2021/22 and the Minutes of the meeting on 18th May record the Resolution. (These Minutes were approved at the meeting on 15th June 2021). All other Members agreed that the procedure had been carried out correctly.

Cllr Cohn proposed that this evening's meeting should continue and this was voted on with 6 for and 1 abstention.

49.21 Public Participation.

- A representative of the Cricket Club said that other groups had been consulted and agreed with the forming of a Sports Association. There had, as yet, been no response from the consultation in the Bradley News. The plan was to have four changing rooms to accommodate all groups. They will maintain the building. It was said that they could get funding for the £300,000 it would cost from a private sponsor whose products would stock the bar. The Members felt that the Cricket Club needed a business plan and a Constitution for the new group before the Parish Council could consider the proposal in full. Also an open meeting for all groups and the residents should be held.
- The Cricket Club advised that the grass cutting/strimming of the playing field boundary wasn't up to their usual standard as they are unable to get volunteers to help. They wished to flag this up now as next year could be a problem.

Resolved: The parish council has concerns the proposed house will be out of character and scale with the surrounding properties. Can the district council confirm that the dimensions of the proposed house, including in particular its height, will be no greater than those in the previous application, 11/2016/17126, for which permission was granted earlier this year?
