

Respective responsibilities of the body and the auditor

This smaller authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The smaller authority prepares an annual return in accordance with proper practices which:

- summarises the accounting records for the year ended 31 March 2016; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review the annual return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report NY0077

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

- The responses given in Section 1, Box 9; Section 2, Box 11; and Box K of the Annual Internal Audit Report are not consistent. Based on the prior year return the council does act as sole trustee and this is supported by the answers given in Boxes 9 and K. The answer in Box 11 should thus be "Yes".
- The total in Box 8 on page 2 should equal the total in Box 7. The difference between the two comprises cheques drawn which had not passed through the bank at 31 March. As such they are classified as payments rather than creditors. Please amend the figures on next year's return, marking Box 8 as restated.
