# Minutes of the meeting of Bradleys Both Parish Council held in Bradley Methodist Chapel school room, 3 Lidget Road, Bradley. BD20 9DS on Tuesday 15<sup>th</sup> April 2025 at 7.30pm.

238.24 Apologies: The apologies from Cllr Smith and reason for absence were approved.

#### 239.24 Recording of Council meetings

#### 242.24 Public Participation.

#### Police:

PC Jefferson advised that the team cover 13 villages and are based at Cross Hills. They distributed details of the messenger service and recommended members and residents to sign up to it. PCSO Cardamone gave the crime figures for March which included 7 incidents of violence, 2 damage to vehicles, 1 ASB and 1 sheep on the road. This was high for the village but was an isolated incident involving one person who has now moved on. A discussion followed about the 20mph limits which the Members were dismayed to hear that it was unenforceable. PC Jefferson would check with their Road Safety team and ask for email clarification.

**Embsay Football Club** The club have requested to use the pitch at Bradley for one season while their home pitch is being refurbished. They would use the pitch every other Saturday around 15 times Aug-May with a maximum of 20 matches. They offered to mark out the pitch and would liaise with the Cricket Club to maintain the ground. This item will be discussed later in the meeting.

#### 243.24 Reports from County Councillor

Cllr Brown reported that the tow path walk Kildwick/Silsden would be finished this month. The NYC Local Plan would take around two years to complete. Although not local, the school transport issue has not been resolved. There were no changes to report on fixed cameras, Connoley's voluntary scheme for speeding was showing some success. The Locality Fund is open though there is only £5,000 to distribute down from the previous £10,000.

#### Pavilion and playing field items

#### 254.24 To consider a request to use the football pitch from Embsay FC

A discussion following on from the public participation and the information given. **Resolved:** That the Members approve the use of the football pitch by Embsay FC if they agree to a single payment of £750 for 15 games, any extra games to be changed at £50 each. The football club to provide details of their insurance and risk assessment. It was also agreed, if possible, that the coach at Embsay would put on a few coaching sessions for Bradley children.

One quote of £330 had been received, further quotes will be sought for the next meeting.

#### **Village & Cemetery items**

#### 256.24 To receive an update on the NDP review.

The next step would be a consultation with the public and statutory bodies. A meeting with the spatial team at NYC would be arranged to discuss the steps for the consultation after Easter.

### 257.24 To receive an update on the blocked drains survey following response from Highways.

NYC had received the grate and footpath surveys but no response had been given. It was noted that there were markings on various roads so it is assumed they are planning the works.

#### 258.24 To receive an update on a village wide 20mph limit.

Following the Police stating that 20mph is not enforceable, clarification would be required. In the meantime the response from the village for their comments had mainly been positive.

The shed has been installed and being treated with preservative before money is spent on equipping it. There is a plant sale and art exhibition on 27<sup>th</sup> April with other events planned.
