


### Agenda item 116.25 Request for funding from Citizens Advice

During the long hot summer, North Yorkshire Citizens Advice & Law Centre (NYCALC) has been earnestly preparing for what will be our busiest time of year, autumn and winter.

The shorter and chillier days place far more demand on people's pockets and see a dramatic increase in people attending our drop-ins, outreach sessions and calling the telephone adviceline. As you will be well aware, everyday living remains expensive with food prices rising and energy bills unpredictable, sadly resulting in hardship for many. Over the last year debt has become an increasingly common problem, with an 18% increase in NYCALC's cases. We are proud that we have been able to help people tackle this distressing issue constructively and enable £3,288,934 of debt to be written off across the county.

NYCALC is committed to being here to provide the advice and legal help necessary to help anyone in North Yorkshire and Bradleys Both overcome their difficulties. Over the last 12 months in Bradleys Both, North Yorkshire Citizens Advice & Law Centre helped 23 clients with 37 issues. The most common problems have been around welfare benefits, financial services and consumer goods.

Good advice really does change lives and without our free, confidential and impartial service, people in Bradleys Both would struggle to find reliable and regulated advice. We are hoping that Bradleys Both Parish Council is in a position to make a donation towards what is an essential local service. We promise that any donation will be used solely for the delivery of advice.

NYCALC knows that it is not always possible to make a gift. If this is the case for you this year, please could we ask instead that you publicise NYCALC's services so the people in Bradleys Both know where to find advice.

# Parish Council Briefing: Approved Policy on Election Recharges

Following approval by North Yorkshire Council's Executive on 16 September 2025, a revised policy on **recharging parish councils for election costs** will be implemented. This change affects both **scheduled elections** and **uncontested polls** and is designed to ensure a fairer distribution of costs across the county. **Key Changes** 

- 1. Scheduled Elections (from May 2027 onwards)
  - Parish councils will be recharged for costs directly attributable to their elections, including:
    - Ballot papers
    - Postal vote packs (if dispatched separately)
  - Where the election is uncontested (insufficient candidates), an uncontested fee of between £50 and £125 will be charged depending on the size of the parish council and the number of seats to cover the costs of candidate nominations.

# 2. Uncontested Elections (from April 2026)

- Costs incurred for uncontested scheduled and by-elections (e.g. printing, officer time) will now be recharged to the relevant parish.
- o Each uncontested by-election typically costs NYC around £250.

### 3. Contested By-Elections

 Recharging for contested by-elections will continue as per existing arrangements.

# **Implications for Parish Councils**

- Parish councils should plan for these costs in their 26/27 and 27/28 budget setting. Invoices will be raised in the month after the election for which the costs were incurred.
- NYC will provide:
  - A written policy, outlining details of which items of expenditure will and won't be recharged
  - Opportunities to meet and discuss the changes. Please get in touch if you would like to discuss
- olndicative cost estimates on request to assist with precept planning. This policy ensures that the cost of parish democracy is met by local residents through the parish precept, rather than being subsidised by all council taxpayers across North Yorkshire.

## Sport Funding

£7million mayoral investment made to get the region moving forward David Skaith, Mayor of York and North Yorkshire, is investing millions to empower communities to become healthier so that everyone can thrive in York and North Yorkshire.

The Mayor's new campaign 'Moving Forward' looks to address regional challenges through four key areas; Movement, Activity and Sport, Active Travel, Men's Mental Health, and Connected to the Outdoors.

Moving Forward has been developed in collaboration with partners from a range of organisations across two groups, the Sports Steering Group and Men's Mental Health Taskforce.

The first milestone is £2.75 million Movement, Activity and Sport funding. Investment will be targeted to support more women and girls to take part in movement, activity and sport, remove barriers for Disabled people by supporting inclusive activities, tackle rural isolation, support early intervention and prevention for health, anti-social behaviour and crime, and enhance skills development and training in the sector.
