Cllr Dancer circulated two proposals for a village wide 20mph limit.

1. Skipton Road

New 30mph sign at Skipton Road Snaygill (currently NSL-60 mph) until the current 30mph sign to be replaced by 20 mph sign.

2. Ings Lane

30mph sign to be retained at lngs Lane (Lane Ends) until a new 20 mph sign installed a safe distance before Swing bridge.

Jacksons Lane

Graduated reduction on Jackson's Lane from NSL 60 mph to 30 mph then to a new 20 mph sign replacing existing 30mph sign.

Crag lane

Graduated reduction on Crag Lane from NSL 60mph to 30mph then to a new 20 mph sign replacing existing 30mph sign.

Cllr Slade reported that Bradley Environmental Group had been awarded £10,000 from the Lottery fund and this is to be used to repair and plant the corner plot at the village hall car park a plan would be produced.

They have been clearing Japanese balsam out of the beck.
