Many thanks for your email. We would respond to the Parish Council's comments as follows:

- 1. Although NYC is not required to consult Parish Councils on property or land disposals where the Parish Council has no legal interest, all transactions are carried out transparently and in line with our responsibilities under Section 123 and NYC's Property Procedure Rules.
- 2. The title would not include excessive restrictions. As standard we would not allow the erection of any structure on the land nor the parking of commercial vehicles. The Local Green Space designation enforces planning restrictions and if the new owners wished to change the use of the land, this would be subject to planning and any other necessary statutory consents. Any sale would purely transfer ownership.
